#### **Course Description:**

Provides students an opportunity to prepare and present current work related to their thesis and dissertation activities. May be repeated. (1H, 1C).

#### **Course Overview:**

This course is a designed to provide students with a broad understanding of teaching and research in hospitality and tourism management. Graduate students are expected to take the course each semester they are in residence at Virginia Tech. The course content is varied to help the student develop a portfolio of teaching and research experiences.

- 3. To develop student capabilities to conduct individual research on selected HTM topics.

- 5. To enhance student understanding of research ethics, protection of human subjects, and conflicts of interest. To create awareness of research ethics compliance procedures at VT.

# REQUIRED ONLINE SEXUAL VIOLENCE PREVENTION COURSE FOR NEW GRADUATE STUDENTS

Dear Colleagues,

This fall, all **new** graduate students will be required to complete an online course on sexual violence: **Haven Plus**. This course is part of the university's comprehensive gender-based violence prevention initiatives and meets requirements of the federal Campus SaVE Act. The course is designed specifically for adult learners and includes information on sexual harassment, sexual assault, stalking, and intimate-partner violence. As you know, these issues significantly impact students on campuses across the country, including our graduate-students.

Students will receive an email with a link to the course on **August 15**<sup>th</sup> (emails will be sent for several weeks to ensure that we reach all students as they enroll). The course must be completed by September 15<sup>th</sup>. Please note that this course is <u>NOT</u> the same as the required employee compliance workshop. Students on assistantship or otherwise employed by the university may also be required to complete the compliance workshop (managed by Equity and Accessibility). The courses are different: Haven Plus addresses their experiences and rights as a *student*, while employee training addresses compliance and their Title IX obligations as an *employee*.
