Good morning and thank you so much! Where do I find the VT Health Insurance Plan online? I'm not able to access my VT email, who should I contact about this issue? I am a VT employee as well and am planning to use my tuition benefits to pay for my course enrollment, what does that process look like?

I have a scholarship from DoD. I have an award letter, but not one that explains the financing. They tell us that "a sponsor letter is uploaded to the SMART Scholar Portal and provided to all Phase 1 scholars in August of each program year. The Sponsor Letter will cover all standard terms in an academic year. The scholar must provide the letter to their school's bursar's office or third-party billing coordinator for SMART to begin paying tuition. The sponsor letter will provide the school with instructions on where to send the invoice. The SMART Program will process tuition payments for the terms beginning after August 1st." That sounds like very tight timing. Should I Can I enroll even if I don't have an US bank account yet? And then when I arrive to Blacksburg and open my account, charge that account in the wallet? Because I will be arriving in August.

Great question, it depends on the department or faculty instructor. Some programs and courses allow it, others are open students in that particular program only. Please check with the instructor of the course - but do so after you've discussed with your own advisor as well.

I found this online: I am an international student and cannot receive some of the required immunization in my country. What do I do?

Please submit all available immunization records to your Healthy Hokies Portal. If you are unable to receive certain immunizations in your country, you may receive your noncompliant vaccines once you have arrived in the US. There is an international immunization clinic on August 14th, 2024 from 9-5 in the Squires Student Center, or you can call 540-231-7621 to schedule an appointment to have it completed here at the health center. You will not be charged for the late fee if you complete the immunizations required upon the start of classes. This exemption is ONLY for international students unable to receive vaccines in their country, not for domestic students who are out of the country for travel.
